See this user's profile for details. HARRISBURG - The Pennsylvania Supreme Court on Friday upheld a judge's order that challenged the legality of the state's polling place Photo ID requirements. The order blocks implementation of the provisions of the state's new Voter ID law until the expiration of the current legislative session in January. A panel of justices in the Pennsylvania Commonwealth Court also ordered the state to allow voters with non-government issued ID to vote at the polling place of their choice. The state appealed that order, but the high court ruled Friday that the lower court's order was correct. Pennsylvanians must present valid photo identification, certified by the Department of Transportation, at the polls on primary and general election days, according to the new law passed in 2011. "The court reaffirmed that it is the core function of the judiciary to decide cases and controversies properly before the court," Chief Justice Debra Todd said in a statement. "Today's unanimous decision by the court in no way prevents the General Assembly from passing legislation designed to further the goal of voter identification, and we are happy that our court, and the judicial system in Pennsylvania, has received a stamp of approval by the United States Supreme Court."
